City of Hastings

The City of Hastings is the county seat for Barry County located in southwestern Michigan. The city has a resident population of 7,500. The household median income is \$59,189 with a household average income of \$74,847. Hastings has both a vibrant downtown district as well as a robust western gateway district that includes many national and regional retail and restaurant businesses. Hastings is home to lively arts and entertainment including sculptures, musical entertainment, and seasonal festivals. Hastings is also home to the Barry Roubaix Killer Gravel Road Race, one of the largest bicycle races of its kind in the country.

Master Plan

The city's master plan supports the development of high-quality place components, including businesses that draw people and have strong elements of "place". Dining and entertainment uses are among the most effective, followed by general merchandise retailers. Mixed use is encouraged. Development of the property for office purposes will not be considered.

The building design characteristics should be like those of other structures in the area. Windows and exterior building materials should reflect building design and form standards consistent with the zoning ordinance.
