I'd like to take this opportunity to offer some insights relating to your search for an airport manager. I am making these suggestions and recommendations based on my observations of the operation of this airport since 1989.

I have been flying at this airport since 1989 and teaching here since 1990. I have operated ultralight aircraft, single engine piston aircraft, multi engine piston aircraft, multi engine turbo prop aircraft, and multi engine jet aircraft. I have also observed the management of this airport under five different managers.

I recommend the manager you choose is a HAC. This is the acronym for humble, accessible, and creditable. By humble, I mean the manager should be approachable and willing to listen to different point of view. They should be able to change their mind when approached with better ideas, and admit when they are wrong. This trait would allow them to be a good "people person".

Accessible means responding to emails, phone calls, or being present at reasonable times of the day. You can't be two places at once, but we need a manager that could be contacted on a daily basis.

The preferred manager should be creditable. When providing information, the information should be accurate and not a best guess. If the answer is unknown, that is a satisfactory answer.

The manager should be expected to manage the airport for the benefit of City, County, and aviation community. We have seen too many instances with some of the past managers where the airport was managed for the benefit of the manager. We need to make decisions that will make the airport more profitable, help it grow, and make it more accessible to the aviation community. The new manager should be held accountable for making profits for the airport not for themselves.

A good manager that has the HAC characteristics should be able to enforce airport rules and at the same time defuse personality problems before they get blown out of proportion.

Managing the airport for the airport community would include items like having a snow plowing policy. We have a few businesses on the field that need to know what to expect when the snow hits. This has been a large change between the managers we've observed. One manager would plow the runway anytime there was more than a inch or two, even while it was still snowing. His belief was that the runway should always be available to an aircraft that may be having an emergency and needing a place to land. He would not do the taxiways or ramps until later. When we would have an early flight, we could always taxi through deeper snow but the runway needs to be clean for takeoffs and landings. Other managers have waited till the snow stopped,

then waited until daylight, then would clean ramps, parking lots, and taxiways prior to the runway. Yet another would simply close the airport until the snow stopped, then wait for daylight and plow through out the following day, then open at their convenience the next evening. We have had some better service plowing service when we used a worn-out pickup truck. With the equipment we have now, we should be able to do much better. We need a policy that will keep the airport open as much as possible while being economical. Economics should play a role in the policy but it should not be the only consideration and at the cost of everything else.

I know how I would like it done, but knowing what the policy would at least help us to decide if the airport will be useable.


I have a lot of other suggestions and would love to work with a manager to help set policies and to make the airport more accessible to all aviators, but my main purpose for writing this is to let you know that I believe Gino Lucci would be a HAC, that he could implement suggestions given to him, and would be easy to work with, and that he has many more qualifications than any manager we've had since 1989 (and probably ever). I think that he is honest, could be blunt and stand his ground, when necessary, without being overbearing or abusing his position. I think he can communicate well and would be an asset when working with the board, local pilots, contractors, state and federal personal, etc.

I believe he would do a good job as our airport manager.
